* **Applications must be received by March 1, 2009**

* The goal of the Exemplary Program is to provide an opportunity for all continuation or alternative schools to reap the benefits of the numerous special programs that have been developed by our members. It is intended that through this process every continuation or alternative school in the state can easily replicate the selected programs.

* The benefits include: Recognition for individuals, schools and districts; the sharing of outstanding ideas that meet the needs of at-risk students; provides a continuity of delivery of services statewide.

* Any current Professional CCEA Member or an employee of a CCEA Member School may submit an application for the Exemplary Program. (There is a limit of one submission per school.)

* All entries must have been in existence for a minimum of two years and demonstrate impact on students and the total school program.

* Complete each required item on the application. (Omissions will automatically disqualify the application.)

* Secure the necessary signatures as designated.

* When completing the item regarding cost replication, please be as specific as possible regarding the key components of the costs to operate the program.

* Please attach any visuals which will help the committee to evaluate your program. (Scrapbooks, portfolios, videos, etc.) These will not be returned unless you specify and provide postage.



Commercial Exemplary Programs
